Pursuant to article 127a of the CAP, during the time limit for submitting a request for reconsideration, the party may waive the right to file the same. On the date of delivery of such waiver to the Minister of Science and Higher Education, the decision shall become final and legally binding.

If the party does not want to exercise its right to request a reconsideration of the case, it may submit a complaint against the decision to the Regional Administrative Court in Warsaw within 30 days of its delivery. The complaint shall be lodged through the Minister of Science and Higher Education. The fixed fee for filing the complaint is PLN 200.

At the same time, I would like to inform you that pursuant to article 243 § 1 and article 244 § 1 of the Act of 30 August 2002 – The Law on Proceedings Before Administrative Courts (Journal of Laws of 2017, item 1369, as amended – hereinafter referred to as the PBAC), the right to assistance may be granted to the party at its request submitted before the proceedings are instituted or in the course thereof. This request is exempt from any court fees. The right of assistance includes exemption from court expenses and appointment of a lawyer or a legal adviser. Detailed rules for the right of assistance are governed by the provisions contained in articles 243-262 of the PBAC.
